## Operation Christmas Child Kicks Off October 14th

Operation Christmas Child will kick off on October 14th and conclude on the Sunday before Thanksgiving. Now is the time to gather those items that kids either need or just can't resist and get ready to pack those boxes.

One change this year is that you can no longer include any liquids or gels or anything that can be ingested in your boxes. This includes items like toothpaste and candy. The reason for this change is that entire shipments of boxes can be held up at Customs if any of them include these items.

Boxes will be available at the Mission table during Fall Festival and in Conklin Hall. You don't have to wait, though. If you have regular shoeboxes, you can pack them, as well.

We collected 124 boxes last year which was down about 25 from 2016. Let's try to get back to that magic 150 number this year.

## Carpet Project Completed

By now everyone should have noticed that the project to replace the carpet in the Sanctuary, Narthex and Chapel is complete. For the first time since the addition to the Sanctuary nearly 20 years ago, all of the carpet in these areas matches. In addition, to better handle spills during communion and candle wax during Advent, the front portion of the Sanctuary has wood-tone luxury vinyl tile installed. The Sanctuary looks better than it has in years.

One change you may not have noticed is that the Chapel, which had doubled as the church library is now solely a chapel. The books and bookcases have been removed, the large desk has been moved to the church office and smaller tables have been set up in the back to allow for counting money on Sundays and for a place for mailboxes for Session and other church groups. This is a great change and gives the room a more spiritual feel.

We want to thank everyone who helped with the project, particularly Alan Paige who coordinated the project and look forward to not doing it again for many years to come..



One would think from our local stores and television ads that Christmas is just around the corner; however, it would appear that a few other holidays, like Thanksgiving for example, are not worth our time and consideration, at least as far as the economy is concerned.

But even before Thanksgiving there is another lesser holiday that garners considerable attention, at least from the younger generation. There are times as well in our day and daily living that we are frightened almost to point of death from various sources.

That is why Psalm 139 continues to be one of my favorite psalms. The writer reminds us there is no place or time that God is not with us. That God knows us better than we know ourselves and so loves us with each and every breath. There is Hope in these words, which we need to be reminded of with each new day. Our Lord put it so well, "*Lo, I am with always, even to the end of the age.*" Matthew 28:20

## News from the Russia Mission

### **2018 Russia Mission Trip Report**

## Solar Electric Study Completed

We've noticed over the last couple of years that our electric bills have been rising and that our demand for power has been increasing. In order to try to reduce the peak demand for electricity, the Building Committee instituted a plan to decrease our simultaneous use of air conditioners during the summer months. This resulted in a savings of about 22% in our peak demand. While our peak demand has dropped, our overall usage of electricity has risen about 7% from last year. Some of this can be attributed to the hotter summer in 2018 but we will need to address this aspect of our energy usage going forward.

Last spring, Guy Schultzman did an evaluation on whether it would be desirable and cost-effective for the church to add solar panels to our buildings in an effort to further reduce our power bills.

### **Should GSPC Go Green?**

#### Is a Solar Electric System Cost-Effective?

Early last spring, Session commissioned the Building Committee to perform an exploratory study to determine whether the installation of Solar Electric Power at GSPC would be cost-effective, at this time. Session's objective was to support global efforts to combat climate change, provided it could be justified as a sound investment.

The Building Committee performed an evaluation of the Church's electrical energy usage and expenses throughout 2017 and prepared a detailed "Request for Proposal" for a Solar Electric System. Three Solar Energy Vendors provided preliminary proposals. The Building Committee evaluated the proposals via a cost/benefit assessment and provided the following recommendations to Session:

- It is not currently cost-effective to deploy a Solar Electric System. The investment "Pay Back Period" is in excess of 18 years. This is primarily due to St. George Utilities' pricing structure for Customer-owned solar production (extra fees) and the Church's inability to utilize available tax incentives.
- Prior to installing a Solar Electric System, the Church would benefit from an "Energy Efficiency Project" to substantially reduce our current energy usage.
- GSPC is currently charged substantial cost penalties for high electrical demand (peak KW usage recorded during each month) during the Summer months. Smoothing this "demand" is a financial priority.

Session approved the Building Committee Study and committed to revisit the evaluation of a Solar Electric System when St. George Utilities revises its fee structure and/or GSPC pays off its current mortgage.

#### How Can You Help GSPC Go Green?

If you still believe that we have a moral imperative to address the environmental impact we have had on our Earth (God's gift of a home to his people), here is what you can do to help:

- 1) Support current efforts to retire the GSPC mortgage through the Building Fund Campaign. (The mortgage will be retired next July.
- 2) Encourage your elected representatives (locally in St. George, at the state level in Utah, and nationally) to encourage development and deployment of alternate energy systems.
- 3) Suggest potential Energy Efficiency initiatives for consideration by the Building Committee.
- 4) Support efforts to reduce Electrical Demand at GSPC during Summer months.

If we all work together, we can get control of our energy usage and help to reduce our impact on our planet.

## Parish Nursing

### **Brown Bag Luncheon:**

On September 19<sup>th</sup>, we were privileged to have Gerene Mason as our Brown Bag speaker. Gerene, a representative from Southern Utah Insurance, is an expert in helping clients wade their ways through the Medicare Part D morass. As an agent, she represents various companies offering Part D plans, helps her client choose the one best suited to their needs, completes the enrollment and advocates for the individual throughout the year at no additional cost to the client because she is reimbursed by the chosen insurance company. Her talk, ahead of this year's Part D Open Enrollment period from October 15<sup>th</sup> to December 7<sup>th</sup>, was both timely and informative. The Enrollment Period is your annual opportunity to enroll for the first time in a Part D plan, change from one plan to another or choose to keep the plan in which you are currently enrolled. The selection you make will take effect beginning January 1<sup>st</sup> of 2019 and extends for the calendar year. If you are enrolled in a Medicare Advantage plan, your drugs are covered under that plan and you do not need a separate Part D plan. Anyone covered under Original Medicare must subscribe, also, to a Part D plan for medications.

## Parish Nursing, continued

### Additional Facts:

- Four Phases to Medicare Part D in the calendar year are—paying a \$415 deductible, if applicable, reaching a full drug cost of \$3820 before entering the Coverage Gap(Donut Hole), being responsible for up to \$5100 out of pocket before finally, entering the Catastrophic Coverage Phase with reduced coinsurance or co-pay for the duration of the year.
- The Bipartisan Budget Act of 2018 will slowly close the donut hole beginning in 2019 so, by 2020, beneficiaries will be paying only 25% of their drug costs while in the donut hole.
- When shopping for a Part D plan – check that your regular meds are covered by the plan’s formulary(list of drugs covered), whether there are restrictions to any of your meds, and confirm that your pharmacy participates in the plan.
- If you do not enroll in Part D coverage, if needed and when needed, you may incur a penalty for that failure which will be added to your costs, indefinitely.
- In 2020, Medigap Plans C and F that cover Part B deductibles will be abolished but if you are already enrolled in one of the plans, you will be grandfathered and may keep the plan.
- Financial assistance is available for securing your medications through the Medicare Part D Extra Help Program.

The entire Part D program can be an annual nightmare but there is help available.

## Session News

Session held their regular monthly meeting on September 9<sup>th</sup>. Here is a synopsis of the actions:

- Approved to accept Kim Rice and Drew Kwako into membership in a Called Session Meeting on September 2, 2018. They, along with Sue Lundgreen, were received into membership and baptized during worship service on September 2, 2018.
- Accepted the resignation of Dennis Peters from Session as Ruling Elder.
- Approved a Russia Mission Travel Authorization Policy, (PO-M-002), stating that "The traveler is a member in good standing of Good Shepherd Presbyterian church, although the Steering Committee, with the approval of Session, may waive this requirement if they believe the trip is in the best interests of the church."
- Approved a Russia Mission Expense Reimbursement Policy (PO-M-003), stating that "The Church will reimburse each traveler who is a member of Good Shepherd Presbyterian Church for round-trip airfare and the cost of obtaining a visa up to a total of \$1,000 per trip. All travel must be approved by the Steering Committee and by Session. The Steering Committee with the approval of Session may waive the membership requirement for reimbursement."
- Approved the recommendations of the Buildings and Grounds Committee and Stewardship Committees regarding the upgrades of Rev. Clingan's and the church secretary's offices, at a cost not to exceed \$3,500, to be paid from the Building Fund.

### A Little Church Humor

A meme is a humorous image, video, piece of text, etc., that is copied (often with slight variations) and spread rapidly by Internet users. In that vein, here is an item submitted by our Pastor for your consideration. Could something like this happen here?

**Huron, SD** – Hundreds were hospitalized and scores more traumatized for life in the wake of a disastrous hymn roll-out this past Sunday.

Recklessly acting in a way contrary to all Lutheran sensibilities, Pastor Norman Schroeder inserted a previously unsung hymn, "Through Jesus' Blood and Merit," into the church service.

"I remember paging to hymn 372 and thinking that it looked unfamiliar," said helpless victim Delores Hamilton from her hospital bed. "My heart started pounding in my chest! My vision narrowed! As we started singing my hands trembled uncontrollably. I felt lightheaded! I don't even think I made it through the first stanza before I passed out."

First responders were overwhelmed by the chaotic scene. Ambulances struggled to make their way through the terrified mob streaming through the church parking lot. Inside the sanctuary, hundreds were incapacitated, many still frozen with their hands clutched over their ears in a vain attempt to shut out the unfamiliar tune. The few conscious congregants were in such a weakened state they were unable to assist their more gravely injured Lutherans.

"We haven't seen such a tragedy since the Reformed Church tried to introduce a contemporary version of the Song of Simeon," lamented local Police Chief Richard Johnson. "Thank goodness there was no loss of life. If we hadn't tasered the organist, the death toll would have been truly catastrophic."

The investigation is only beginning, but already red warning lights are flashing in the eyes of any common sense Lutheran. Why didn't Pastor Schroeder run his plans through the worship committee? Why wasn't the hymn tune introduced as postlude, prelude, and offertory? Why weren't congregants warned the standard three months in advance that a new hymn was being introduced?

Only a fair, impartial investigation and the immediate excommunication of Pastor Schroeder can ensure such a tragedy never occurs again.

## Building Fund Update

As you all know, we have a mortgage payment of \$1,343.51 due each month. The mortgage has a principal of \$184,117 and a 15-year term which means that if it goes for its full term (although we expect to pay it off early), we will pay a total of \$241,831.80. We also have several major maintenance items over the next several years, totaling more than \$145,000, that need to be funded in addition to paying off the mortgage, meaning we need to raise a total of \$384,000.

Our first two campaigns produced \$195,063. Through September 23<sup>rd</sup> we have received pledges towards our third campaign totaling **\$54,100** and additional cash donations of **\$9,819** for a total of **\$258,982** or about **67.4%** of our new **\$384,000** goal.

Thanks to everyone who has made a pledge to the third campaign. If you haven't pledged, please prayerfully consider making a pledge to help us pay off the mortgage early and have sufficient funds to cover maintenance and make other improvements in the next three years.
